**SUMMARY OF LEGISLATION BEFORE
THE JOINT STANDING COMMITTEES**

AUGUST 1995

This document is a compilation of the bill summaries prepared by this office for the Joint Standing Committees of the Maine Legislature. The volume is organized alphabetically by committee; within each committee, the summaries are arranged by LD number. A subject index is provided at the beginning of each committee's summaries. The publication, History and Final Disposition of Legislative Documents, is helpful in determining to which committee any particular bill was referred.

In this document, the committee report or reports, the prime sponsor for each bill and the lead co-sponsor in each house if one has been designated are listed below each bill title. All adopted amendments are listed, by paper number, together with the sponsor for floor amendments. Final action on each bill is listed to the right of the title. Various categories of final action are abbreviated as follows:

CARRIED OVER	<i>Bill carried over to Second Session</i>
CON RES XXX	<i>Chapter # of Constitutional Resolution passed by both Houses</i>
CONF CMTE UNABLE TO AGREE	<i>Committee of Conference unable to agree; bill died</i>

An Act Concerning Municipal Electric Districts and the Development of a Competitive Energy Market

This bill proposed to require the Public Utilities Commission to approve the formation of a new municipal utility district whenever the formation has received a favorable vote of a majority of the municipalities' voters.

The bill also proposed to establish as a policy of this State the encouragement of a competitive market for electrical energy and to require the Public Utilities Commission to give explicit consideration and weight to this policy in its decisions.

LD 1533 An Act to Require the Public Utilities Commission to Ensure Telecommunications Service in Economic Development Areas

This bill proposes to direct the Public Utilities Commission to allow special rates for telecommunications services to commercial and industrial customers located in economic development areas.

This bill proposes to create the Prospect Water Authority.

LD 1567 An Act to Facilitate Sewer and Water Main Extensions

CARRIED OVER

Current law requires, prior to constructing an extension, that a sewer district obtain assurance from the municipality through which the extension will pass that the extension and the user of the extension are in conformance with the municipality's plans and ordinances. Notice of the proposed extension must be published in a newspaper of general circulation.

This bill proposes to repeal those requirements and instead to require the sewer district to consult with the municipality to determine compliance. This bill also proposes to require the licensing authority to obtain a bond from a private installer of a sewer or water line.
