Summary Of Legislation Before The Joint Standing Committees August 2001

Enclosed please find a summary of all bills, resolves, joint study orders, joint resolutions and Constitutional resolutions that were considered by the joint standing select committees of the Maine Legislature this past session. The document is a compilation of bill summaries which describe each bill and relevant amendments, as well as the final action taken. Also included are statistical summaries of bill activity this session for the Legislature and each of its joint standing committees.

The document is organized for convenient reference to information on bills considered by the committees. It is organized by committees and within committees by bill (LD) number. The committee report(s), prime sponsor for each bill and the lead co-sponsor(s), if designated, are listed below each bill title. All adopted amendments are listed by paper number. Two indices, a subject index and a numerical index by LD number are provided for easy reference to bills. They are located at the back of the document. A separate publication, <u>History and Final Disposition of Legislative Documents</u>, may also be helpful in providing information on the disposition of bills. These bill summaries also are available at the Law and Legislative Reference Library and on the Internet (www.state.me.us/legis/opla).

Final action on each bill is noted to the right of the bill title. The abbreviations used for various categories of final action are as follows:

Members of the task force are appointed jointly by the Speaker of the House and the ranking leader of the House Republicans and the President and President Pro Tempore of the Senate and consist of municipal officials, a representative of the League of Women Voters of Maine, public members, representatives of the major political parties, the State Information Officer, the Secretary of State and staff from the Secretary of State's office. The task force is required to report to the Joint Standing Committee on Legal and Veterans' Affairs.

LD 199 proposed to amend the Constitution of Maine to bar for 6 years the direct initiation by a citizen of legislation that was rejected by the people of the State. Under this resolution, the issue of whether an initiative is
