Re: Bill Summaries, 120th Legislature, 1st Regular Session

Enclosed please find a summary of all bills, resolves and Constitutional resolutions that were considered by the Joint Standing Committee on Appropriations and Financial Affairs during the 1st Regular Session of the 120th Legislature. The summary describes each bill and relevant amendments as well as the final action. Also included is a statistical summary of bill activity by the committee. Please note the effective date for all non-emergency legislation enacted in the 1st Regular Session (unless a later date is specified in a particular law) is September 21, 2001. Joint orders are effective when passed.

The document is organized for convenient reference to information on bills handled by the committee this session. It is organized by bill (LD) number and two indices are located at the back of the document that group bills by subject and by LD number. Final action on each bill is noted to the right of the bill title. The abbreviations used for various categories of final action are as follows:

LD 457 An Act to Clarify that the Sales Tax Exemption for Purchase of Manufacturing Equipment Applies Equitably CARRIED OVER Sponsor(s) MICHAUD MH Committee Report S-100 Amendments Adopted S-100

LD 457 proposed to include television and radio broadcast signals within the definition of "tangible personal property" under the sales tax law for the purpose of including machinery used to produce the radio and television broadcasts within the existing manufacturers' sales tax exemption that is currently utilized by the print media.

Committee Amendment "A" (S-100) proposed to move the changes provided by the bill from a definition section in the law to a sales tax exemption section in the law to accomplish the intent of the bill more appropriately.

LD 457 was originally referred to the Joint Standing Committee on Taxation. When removed from the Appropriations Table it was referred to the Joint Standing Committee on Appropriations and Financial Affairs and carried over to the Second Regular Session.
