Re: Bill Summaries, 120th Legislature, 1st Regular Session

Enclosed please find a summary of all bills, resolves and Constitutional resolutions that were considered by the Joint Standing Committee on Appropriations and Financial Affairs during the 1st Regular Session of the 120th Legislature. The summary describes each bill and relevant amendments as well as the final action. Also included is a statistical summary of bill activity by the committee. Please note the effective date for all non-emergency legislation enacted in the 1st Regular Session (unless a later date is specified in a particular law) is September 21, 2001. Joint orders are effective when passed.

The document is organized for convenient reference to information on bills handled by the committee this session. It is organized by bill (LD) number and two indices are located at the back of the document that group bills by subject and by LD number. Final action on each bill is noted to the right of the bill title. The abbreviations used for various categories of final action are as follows:

An Act to Enhance Economic Development Capacity

Sponsor(s)Committee ReportAmendments AdoptedMICHAUD MHS-212SAXL

LD 1144 proposed to appropriate \$2,000,000 in each year of the biennium to the Department of Economic and Community Development. It proposed \$1,200,000 annually to continue the department's business attraction marketing program and \$800,000 annually for block grants to regional economic development districts for locally determined priority issues and needs such as responding to defense conversion issues, coping with the loss of a major employer, responding to long-term patterns of downsizing in a mature or dominant business sector or helping to develop grass roots economic development capacity in underserved communities and areas through organizational development, coalition building and staffing assistance.

Committee Amendment ''A'' (S-212) proposed to reduce the amount appropriated for regional block grants to \$600,000 annually and to provide additional grant procedures and requirements. The amendment also provides \$200,000 annually for start-up operating assistance to develop local and regional economic development programs.

LD 1144 was carried over to the Second Regular Session.
