Re: Bill Summaries, 120th Legislature, 1st Regular Session

Enclosed please find a summary of all bills, resolves and Constitutional resolutions that were considered by the Joint Standing Committee on Appropriations and Financial Affairs during the 1st Regular Session of the 120th Legislature. The summary describes each bill and relevant amendments as well as the final action. Also included is a statistical summary of bill activity by the committee. Please note the effective date for all non-emergency legislation enacted in the 1st Regular Session (unless a later date is specified in a particular law) is September 21, 2001. Joint orders are effective when passed.

The document is organized for convenient reference to information on bills handled by the committee this session. It is organized by bill (LD) number and two indices are located at the back of the document that group bills by subject and by LD number. Final action on each bill is noted to the right of the bill title. The abbreviations used for various categories of final action are as follows:

Amendments Adopted

LD 1646 proposed to appropriate \$750,000 in fiscal year 2001-02 to the Maine State Library to fund on-line reference materials in order to provide less costly and more equitable access to organized, reliable, valid and age-appropriate information for all Maine citizens from school, home or library through statewide licensing of reference materials.

Senate Amendment "A" (S-398) proposed to replace the bill with a requirement that upon application from the Board of Trustees of the University of Maine System to the Public Utilities Commission, the commission would be required to order Verizon to transfer \$500,000 from the unexpended balance of the Maine School and Library Network project as of June 30, 2001 and \$500,000 as of June 30, 2002 to the University of Maine System no later than October 1, 2001 and August 1, 2002, respectively, to provide for the infrastructure needs to create a digital library that is accessible statewide.

An appropriation of \$200,000 to the Maine State Library in each year of the biennium was included in the Part 2 Budget Bill, Public Law 2001, chapter 439, Part IIII to fund statewide licensing of reference materials and the creation of a statewide database of reference materials. See LD 855.
