Summary Of Legislation Before The Joint Standing Committees May 2002

Enclosed please find a summary of all bills, resolves, joint study orders, joint resolutions and Constitutional resolutions that were considered by the joint standing select committees of the Maine Legislature this past session. The document is a compilation of bill summaries which describe each bill and relevant amendments, as well as the final action taken. Also included are statistical summaries of bill activity this session for the Legislature and each of its joint standing committees.

The document is organized for convenient reference to information on bills considered by the committees. It is arranged alphabetically by committee name and within committees by bill (LD) number. The committee report(s), prime sponsor for each bill and the lead co-sponsor(s), if designated, are listed below each bill title. All adopted amendments are listed by paper number. Two indices, a subject index and a numerical index by LD number are provided for easy reference to bills. They are located at the back of the document. A separate publication, <u>History and Final Disposition of Legislative Documents</u>, may also be helpful in providing information on the disposition of bills. These bill summaries also are available at the Law and Legislative Reference Library and on the Internet (www.state.me.us/legis/opla).

Final action on each bill is noted to the right of the bill title. The abbreviations used for various categories of final action are as follows:

Enacted Law Summary:

Resolve 2001, chapter 122 provides a General Fund appropriation of \$25,000 in fiscal year 2002-03 to support scholarships for the Seeds of Peace International Camp in Otisfield.

LD 1938 An Act to Make Changes to the Respite Care Fund Administered PUBLIC 487 by the Department of Human Services

Sponsor(s)	Committee Report	Amendments Adopted

LD 1938 proposed to appropriate \$250,000 in fiscal year 2002-03 to the Department of Human Services, Bureau of Elder and Adult Services to serve as the 25% state match for the federal family caregiver initiative under Title III-E.

Committee Amendment "A" (H-771) proposed to replace the bill. It proposed to make changes to the Bureau of Elder and Adult Services' Respite Care Fund within the Department of Human Services and proposed to authorize the department to designate an amount from the fund to carry out the purposes of the National Family Caregiver Support Program. It also proposed to change the title and add a fiscal note to the bill.

Enacted Law Summary:

Public Law 2001, chapter 487 authorizes the Department of Human Services, Bureau of Elder and Adult Services to designate an amount from the Respite Care Fund to carry out the purposes of the National Family Caregiver Support Program.

LD 1957 An Act to Allow the State to Maximize Funds for Meals for the Elderly in the State

<u>Sponsor(s)</u> SAXL MICHAUD MH Committee Report ONTP Amendments Adopted

LD 1957 proposed to provide additional funding to the Meals on Wheels program within the Department of Human Services, to be matched by federal funds.
