LEGISLATIVE DIGEST OF BILL SUMMARIES AND ENACTED LAWS

This Legislative Digest of Bill Summaries and Enacted Laws summarizes all LDs and adopted amendments and all laws enacted or finally passed during the First Regular Session of the 125th Maine Legislature.

The *Digest* is arranged alphabetically by committee and within each committee by Legislative Document (LD) number. The committee report(s), prime sponsor and lead co-sponsor(s), if designated, are listed below each LD title. All adopted amendments are summarized and listed by paper number. A subject index is included with each committee. The appendices include a summary of relevant session statistics, an index of all bills by LD number and an index of enacted laws by law type and chapter number.

Final action on each LD is noted to the right of the LD title. The following describes the various final actions.

Joint Standing Committee on Inland Fisheries and Wildlife

Enacted Law Summary

Public Law 2011, chapter 355 provides that the Commissioner of Inland Fisheries and Wildlife may allow a person to accompany and assist a blind resident, a paraplegic resident, a resident disabled veteran, a person with an acquired brain injury, a patient or inmate residing in a state institution or a person with a developmental disability who has a complimentary fishing license to fish without obtaining a separate fishing license.

Public Law 2011, chapter 355 was enacted as an emergency measure effective June 15, 2011.

LD 1121 An Act To Provide for Incentives and Reparations to Landowners in Connection with All-terrain Vehicle Access

This bill creates 2 funds concerning all-terrain vehicles, to be administered by the Department of Inland Fisheries and Wildlife:

- 1. The ATV Trail Fund, which provides all-terrain vehicle trail planning, clearing and construction assistance to landowners that commit to the creation or improvement of multiuse trails and that allow all-terrain vehicles on their properties; and
- 2. The ATV Mitigation Fund, which compensates private and public landowners for damage caused by all-terrain vehicle use, overuse or abuse on their properties.

The funds will be capitalized with a \$2 charge on each all-terrain vehicle registration fee and a 2% added sales tax on the sale of an all-terrain vehicle to residents of other states; additionally, violators of all-terrain vehicle operation law may elect to have a portion of their fines deposited into the ATV Mitigation Fund.

LD 1208 An Act To Allow Early Deer Hunting for Senior Hunters

This bill provides that the day before the deer hunting season starts is open to a holder of a valid junior hunting license who is under 16 years of age and a holder of an antlerless deer permit who is 70 years of age or older.
