Recommendations on the "Part 2" Budget

Pursuant to Joint Rule 314, subsection 4, we are providing our comments on the portion of the Part 2 budget that affects matters within the jurisdiction of this committee.

Our committee is aware of only one such provision: the provision in Part C of the bill that moves certain federal funds and other special revenue associated with three positions that were moved from DECD to the PUC in the Part 1 budget. We understand the provision to be merely an accounting change that moves the funds from the Administrative Division to the Conservation Administration Fund and has no net financial impact. We understand this accounting change is acceptable to the PUC. Our committee has briefly review the provision and has no objection to it.
